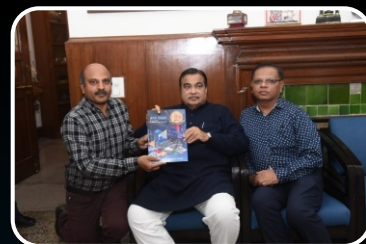
Objective

The award seeks to: **Encourage Best Practices, Recognize Individual Contributions, Foster Innovation and Quality, Promote Skill Development, Support Sustainable Growth, Inspire Industry Stakeholders** by achieving these objectives, the ISDA Award aims to elevate the standards of the Indian construction sector, ensuring its continued growth and development in a manner that is sustainable, innovative, and aligned with the best global practices.

Best International Project



Guidelines for Nominations in each Award Category:

1. Best Professionally Managed Company:

Objective: To recognize companies that demonstrate professional management practices, innovation, leadership and strong financial performance while contributing to sustainable development & corporate governance.

Eligibility: Open to large, medium and small Construction Companies, Consultants, Manufacturing Companies, in continuous business from last 05 years, having track record of financial stability and growth over the last three years.

Evaluation Criteria: Evaluators may like to verify financial performance, corporate governance, innovation and technology adoption, human resource and talent management, sustainability & social impact, leadership & strategic vision.

2. Best Construction Project:

Objective: To recognize and honor excellence in the design, construction, and delivery of outstanding building and infrastructure projects.

Eligibility: Open to all construction and infrastructure projects completed recently or within the last 2 years.

Evaluation Criteria: Evaluators may like to verify the Quality of Construction, Structural integrity, safety measures, and adherence to standards, Use of new technologies or methods, PEB, Precast, Environmental impact and use of sustainable practices, Green Practices, Restoration Techniques Contribution to local and National Economy.

3. Best HSE Project:

Objective: To promote and recognize outstanding safety practices and quality assurance in the construction industry.

Eligibility: Open to projects or companies demonstrating excellence in safety and quality practices.

Evaluation Criteria: Evaluators may like to verify adherence to safety regulations and implementation of safety practices, Processes and systems for ensuring high-quality output, Innovation in Safety, Introduction of new safety technologies or practices, Incident-free records and continuous improvement in safety and quality.

4. Best Quality Project:

Objective: Recognize excellence in quality of construction/ infrastructure..

Eligibility: Minimum 50% physical progress achieved at the time of application.

Evaluation Criteria: Compliance with approved design, drawings and specifications. Adherence to all applicable codes. Active QMS implementation backed by documented internal and third-party audit reports. Material Testing and Certificates with proper records. Workmanship & Method Statements records.

5. Best Individual Contribution Awards:

Objective: To recognize individuals who have made significant contributions to the construction industry through their leadership, innovation, and dedication.

Eligibility: Open to individuals in the construction industry, including project head, safety head, HR Head and rising stars.

Evaluation Criteria: Evaluators may like to verify the significant accomplishments in the construction industry, Ability to lead teams and manage complex projects, Personal contributions to innovative practices in the field, adherence to ethical standards and integrity in the profession, leadership qualities, and special emphasis would be on implementation of best safety practices for specific category. Evaluators shall also verify the innovative and best HR practices / marketing and Branding practices implemented by Professionals.

6. Best Material Manufacturing / MSME Organizations:

Objective: To recognize & honor Large / MSMEs engaged in the manufacturing of construction materials that have demonstrated excellence in innovation, quality & Sustainability, contributing significantly to the construction Industry.

Eligibility: Registered as an MSME, functioning from minimum last three years, demonstrated financial stability and compliance with environmental standards.

Evaluation Criteria: Evaluators may like to verify the adoption of new technologies in manufacturing process, adherence to quality standards, implementation of eco friendly practices, consistent growth & contribution to the construction sector and National Economy.

7. Specialized Sector Awards:

Objective: To acknowledge excellence in specialized areas such as green building, urban development, heritage restoration, and more.

Eligibility: Open to projects in specialized sectors such as green building, urban development, heritage restoration, etc.

Evaluation Criteria: Evaluators may like to verify adherence to standards and best practices in the specialized sector, Innovative approaches within the specialized sector (CSR, skill development, Academia & Large manufacturing organizations), Social, economic, and environmental impact of the organizations / Institutes/ Plants, Long-term sustainability and conservation efforts.

8. Best International Project:

Objective: To recognise and honour excellence in projects executed by Indian organisations on an international platform, demonstrating outstanding performance, innovation, quality, sustainability, and successful project delivery..

Eligibility: The project should be executed by an **Indian PSU, Contractor, Developer, Consultant, or Architect**, who has made a **significant contribution** to the project.

Evaluation Criteria: For applications under Best Construction Project, the project should have been executed/completed within the last two years. If applying under both Best Project and Best Safety, the project should be at least 50% completed at the time of application. The applicant/project must meet all other eligibility criteria and conditions specified under the respective Best Project and Best Safety categories.

Important Instructions:

- The last date for accepting the nominations may be extended as per the discretion of the jury.
- The Evaluation Process includes scrutiny of Application form, followed by e- interactions and physical verification (except individual's category) to the project/plant/office location.
- Minimum two evaluators from ISDA shall visit the project location and their travel (By Air), accommodation and local hospitality shall be borne by the applicant organization.
- The selection and rejection of nominations shall depend on the opinion of the Jury and no communication in this regard shall be entertained by ISDA.
- All Awards can be received by the senior representatives of the organizations; a maximum of three persons can join in receiving the Award.
- These awards are given to appreciate the best practices and encourage the participants to perform even better and others to follow the suit.
- Who should apply- The award is open to all the stake holders of Construction/ Infrastructure sector including concerned material manufacturers, research and development institutions & Academia.
